Appointment and removal of trustees:

a. The founders hold office as trustees for their life time or until they resign. The members of the Trustees may by unanimous decision elect one or more persons as members of the Board of Trustees to fill any vacancy in the Board of Trustees within the limits specified herein in this deed. Any person appointed by the Board of Trustees shall hold office for such period as may be determined by the Board at the time of his appointment or until his voluntary resignation. Except the life time members a trustee may be removed during his post by a majority decision of the trustees committee.

The number of members shall have the right to combine more than one member into a group and to increase the number of members, provided that such single member group shall, within a period of three months from the date on which the number of members is reduced to one, at least double the number of members of the group from which such member has been appointed.

Powers of the Board of Trustees:

The Board of Trustees shall have all necessary powers to effectively carry out the objectives of the Trust.

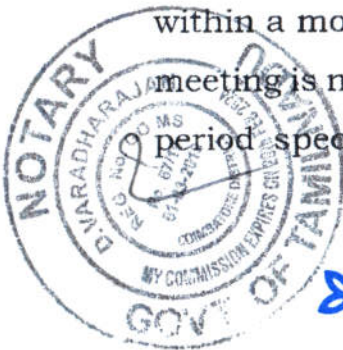
c. To ensure that the activities and endowments of the Trust are subject to the procedures specified in Sections 2(15), 11, 12, 13 and 80G of the Income Tax Act.

- x. Confronting/initiating legal proceedings against/on behalf of the Trust and its Trustees, seeking out-of-court settlement of all suits, and conciliating other proceedings.
- xi. Appoint necessary Managers, secretaries, clerks and other employees, appoint employees and agents, recruiting and dismiss to manage the management of the trust.
- xii. To do all things lawful or necessary or expedient for the management of the day-to-day affairs of the Trust.

PROCEDURE OF THE BOARD OF TRUSTEES:


a. The meeting of the Board of Trustees shall be held at least once every three months. The time gap between two meetings should not exceed ninety days. These meetings may be held at the registered office of the Trust or at such other place as the Board of Trustees may decide. The Trustee may hold such additional meetings as may be necessary to consider any matter relating to the Trust.

b. The Managing Trustee will act as Chairman of the Board of Trustees. A meeting of the Board may be convened by the Chairman suo motto or at the request of at least two members of the Board. When a request is received from the members for holding a committee meeting, a committee meeting should be convened by the Chairman, within a month from the date of receipt of such request. If any such meeting is not convened by the chairman of the committee within the period specified above, the claimants themselves may convene a

meeting of the committee within thirty days of the expiry of the period specified above.

- c. Committee meeting, with not less than seven days' notice, the date of the meeting, Notice containing the place, time and nature of the business to be transacted at the meeting shall be sent to each trustee by registered post, certified mail or speed post. With the consent of all the members of the group, the notice may be sent in electronic form such as email, SMS or other means of communication such as telephone, fax. The proceedings of the meeting shall be deemed to have been valid even if the notice has not reached any of the trustees after being so sent.
- d. A meeting of the Committee may be convened by not less than seven days' notice with the consent of all the Trustees.
- e. Half of the number of members of the Board shall constitute a quorum for each meeting of the Board. If they are not required, the meeting will be postponed to the same day and time of the following week. The members may hold a meeting there even though they are not required to so adjourn.
- f. The Trustee shall attend the meeting of the Trustees directly. Instead, the trustees may express their views in writing on matters to be transacted at the meeting before the commencement of the meeting.
- g. In the absence of an Executive Trustee at a meeting, the Trustees may appoint one of their member as Chairman of the Committee meeting.

- h. Any matter in which there is no consensus among all the Trustees shall be decided by a majority of the Board. The chairman of a meeting where there is an equal division of votes may cast his casting vote.
- i. A minute book shall be maintained and the proceedings of every meeting of the Board of Trustees shall be recorded. And it should be signed by the chairman of the meeting. The copies of the Resolutions passed in the meeting should be provided to members as soon as possible.
- j. Trustees may appoint personal co-trustees for themselves. Such Co Trustees shall act to manage the affairs of the trust on behalf trustees who has appointed them. The co-trustees shall not participate in Board of Trustees meetings.
- k. Any trustee subject to the provisions of this deed may at any time, with the consent of all other trustees, delegate his duties or powers to any other person or persons. That person may also be an another trustee.
- l. The Trustees may receive from the Trust Fund for expenses incurred in carrying on the affairs of the Trust and attending meetings of the Trustees.
- m. A majority decision of the Board of Trustees shall be necessary for the following:
- 1) To buy or sell immovable property
 - ii) From time to time the Board of Trustees may purchase property for an amount in excess of the limits decided by the trust committee or dispose of movable property for an lesser amount.

- iii) To appoint trustees
- iv) Acquisition of existing companies and start of new companies
- v) The above objectives for the Trust to undertake new ones apart from the existing objectives
- vi) To invest the surplus fund of the Trust beyond the amount fixed by the Committee from time to time,
- vii) To grant transaction authority in respect of bank accounts.
- viii) Other trustees may act even if there is a vacancy in the board of trustees.

Managing Trustee:

a. Mr.K.Vaithyanathan will act as the Managing Trustee of the Trust. After the term of his office one of the Trustee shall be appointed by a majority decision of Board as an Executive Trustee.

b. The Executive Trustee may hold office for a term of three years. He may continue to hold the office of Executive Trustee until he remains as a member of the Board of Trustees or he voluntarily resigns from the office of Executive Trustee.

c. After three years. The trustees shall elect one of their number as an executive trustee for the next three years. If the Committee wishes to re-elect the previous Managing Trustee, it may do so.

d. The Executive Trustee shall look after the day-to-day affairs of the Trust with the advice of the Trustee and the direction of the Board.

e. Trustees rely on the General Administrative Trustee for the safe keeping of all assets and records of the trust. The Board of Trustees shall also act as the Trustee's representative in the legal forums. He will

sign documents in a series of legal cases. He will go to court. Also act as representative of the trust in Government Offices.

Secretary:

a. Mr.K.Nagarajan will act as the Trust Secretary. After his term of office the Trustee shall be appointed by a majority decision of the Board of Trustees as a Trustee Secretary.

b. The Secretary may hold office for a term of three years. And he can hold the office of Secretary till he remains as a member of the Trustees or until he voluntarily resigns the office of Secretary. After lapse of three years, the trustees must elect one of their own as secretary for the next three years. If the committee wishes to re-elect the previous treasurer then it can re-elect.

c. The Secretary shall maintain the agenda and other documents and records of the Board of Trustees meetings.

d. The Secretary shall be responsible for the day-to-day administrative activities of the Trust. The Secretary should send replies in consultation with the Executive Trustee and/or Treasurer who will handle correspondence received by the Trust.

Treasurer:

a. Mr. K.Nagarajan shall act as Treasurer. After his term of office of the Trust and a Trustee shall be appointed as Treasurer by a majority decision of the Board of Trustees.

b. The Treasurer may hold office for a term of three years. He may hold the office of Treasurer as long as he remains a member of the Board of Trustees or until he resigns as Treasurer. After three years, the Trustees shall elect one of their number as Treasurer for the next three years. If the committee wishes to re-elect the previous treasurer then it can re-elect.

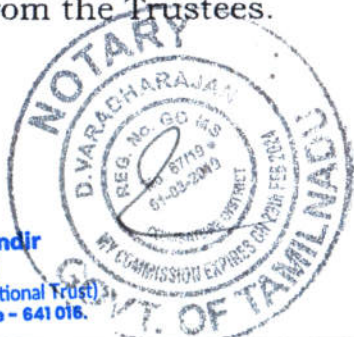
c. The Treasurer is responsible for preparing the annual budget, preparing monthly and annual expenditure reports, submitting the budget and financial statements audited by an auditor duly appointed by the Board of Trustees for approval before the meeting of the Board of Trustees. The Treasurer shall be responsible to maintain books of account of the Trust, to prepare money vouchers, to receive contributions for payment and to sign for sums or goods received by the Trust, for receipts and annual statements of revenue and expenditure and for preparing monthly statements. The Treasurer shall periodically upload the register of assets of the Trust and place it before the Board of Trustees for approval.


d. The treasurer is responsible for the safe keeping of the funds of the trust.


Management of the Trust:

To carry out the activities of the Trust towards the above mentioned objectives and to raise and manage its funds. The Managing Trustee shall have the power to set up sub-committees among the Trustees to assign duties and receive recommendations if guidance or support is required from the Trustees.

If a meeting with government officials is necessary in connection with the operations of the Trust, both the Executive Trustee and the Secretary shall attend such meetings. If either the Executive Trustee or the Secretary is unable to attend such meeting for any reason, the person attending the meeting shall notify the other person in writing of the proceedings of the meeting.

Security of documents:

For the time being all documents and books of account relating to the assets and investments of the Trust and other records relating to the Trust shall be in the custody of the Managing Trustee.

Bank Accounts:

Mr.Vaithiyanathan and Mr.K.Nagarajan are jointly authorized to sign applications for bank cheques, drafts and payment instructions, to withdraw money from the bank and carry out other bank account related transactions. Trustees or other persons may be authorized by a majority decision of the Board of Trustees. The Board of Trustees has the power to make appropriate changes in the bank account operations from time to time.

A current account should be opened in the name of the trust in a nationalized bank. All income of the Trust, subscriptions, donations and proceeds of investments shall be paid into the designated bank account of the Trust. Periodic withdrawals from bank account can be done as required for expenses.

Accounts and Audit:

- a. The Board of Trustees shall maintain up loaded books of all income and expenditure of the Trust. Further shall prepare an Income and Expenditure Account and Balance Sheet for each financial year ending on 31st March.
- b. The accounts should be audited every year by a Chartered Accountant or a firm of Chartered Accountants. They shall be appointed by the 'Board of Trustees'. The audited accounts may be placed at any meeting of the 'Board of Trustees' held before the end of six months from the end of the financial year.


Seeking Arbitration:


- a. In case of any dispute regarding the day-to-day functioning of the Trust or any disagreement regarding the sections, clauses or provisions of this deed, the matter should be referred to a retired judge of a civil court or a person of repute in the society for justice/opinion. In case of disagreement in the selection of an arbitrator, a three-member arbitrator shall be constituted.
- b. The trustees must accept the decision of the arbitrator or the majority decision of the arbitrator without tending to question it in any court.


Others:

In no case shall the assets of the trust be divided among the trustees.

Apart from the capital of Rs.25,000/- (Rupees twenty five thousand) in the name of this trust, this trust has no assets of its own.
